Thank you for being part of WSBACommunity. By joining and using WSBACommunity, you agree that you have read and will follow these rules and guidelines. You also agree to limit discussions, shared files, and other content to what is best suited to the purpose of the online community, which is to provide a forum for ongoing public conversation, collaboration, shared document storage, meeting scheduling and logistics. Activity on WSBACommunity does not replace an entity meeting. You agree that discussions taking place in WSBACommunity will be consistent with the open public meetings provisions of WSBA's Bylaws as well as any applicable court rules.

To preserve an environment that encourages both civil and generative dialogue, we reserve the right to suspend or terminate membership in this community for anyone who violates these rules. Violations of these policies will be addressed on a case-by-case basis and may result in warnings, removal of the violating content, or termination of the users' access to the site. #### **Code of Conduct**

### All Users

- 1. Respect others. Focus responses on the content of posts and not on the people making them. All users should assume the good intent of others while also being accountable for their impacts.
- Respect the purpose of the community. Use the community to converse, engage, collaborate on your WSBA volunteer-related work, engage with the group in a respectful way.
- 3. All defamatory, abusive, profane, threatening, offensive, or illegal materials (messages and documents) are strictly prohibited.
- 4. Information posted on the discussion groups and in the libraries is available for all to see and could be released in response to a public records request. As such:
  - a. Comments must comply with laws, including libel, slander, and antitrust laws.
  - b. Do not post confidential information or messages by any means. There are no facilities provided by this site for sending or receiving confidential messages and, notwithstanding that a message on this site may be marked as confidential, it may be read by others for whom it was not intended.
  - c. Do not post personally identifiable information for yourself or others. This includes a person's name or first initial and last name in combination with any of the following: social security number, driver's license number or Washington identification card number, account number or credit or debit card number, any combination of account numbers and access codes or passwords that can be used alone, or in combination with other information to access a person's financial accounts, full dates of birth, student, military or passport identification numbers, health insurance policy numbers or identification numbers, any information about a

person's medical history or mental or physical condition or about a health care professional's medical diagnosis or treatment of any person, biometric data, or user name and email addresses in combination with passwords or security questions and answers that would permit access to an online account

- 5. Respect intellectual property. Post content that you have personally created or have permission to use and have properly attributed to the content creator.
  - a. When posting items in our collaborative environment, please indicate if the item is not available for reposting. It's also advisable to contact the owner of any material if you would like to repost.
- 6. Posts messages or documents that are relevant and only to the most appropriate communities.

### **Terms of Use**

WSBA*Community* is provided as a service for the members of the WSBA or of its entities, for legitimate WSBA business use. Violation of the below may result in the loss of access privileges.

Inappropriate use include, but are not limited to:

- 1. Using the site by minors: must be 18 years of age or older to participate.
