

This letter is intended to be an application to serve on the Washington State Bar Association's Limited Practice Board. I understand from a notice recently received that a position is open or may be coming open in the near future. I understand further you are the current Board Chair. I am interested in joining you and the others. Please forward this information to the powers that be for my qualifications to be considered for the position.

I have not prepared a resume in decades and doubt that I would be all that proficient if I tried. Permit me to submit for the Board's consideration the information below together with my law firm's website: www.sargeantlegal.com. I am optimistic, if it would be useful, you might consider recommending me for the position based on our long-standing professional and personal relationships.

I was admitted to practice and sworn in by the Washington State Supreme Court in 1982. I have been an active member of the WSBA in good standing since. I am also admitted to practice in Alaska and Oregon. My office is located in Walla Walla; my law practice covers all of Washington, as well as Oregon and Alaska. I focus my time professionally on real estate matters, both transactions and litigation, representing parties to transactions, lenders, licensed brokers, title companies (agents and underwriters) in both escrow and title insurance aspects of the industry.

I recently served as the President of the American College of Mortgage Attorneys, having previously been elected as Secretary, Treasurer and President-elect; I contributed multiple terms and many years as committee chairs in several capacities. Through my active participation in the College, I have relationships that generate referrals for local counsel services representing mortgage lenders and borrowers in commercial transactions.

I am currently a member of the Board for the CCIM Washington Chapter, of which I have been a member for several decades. I am often engaged to represent licensed brokers and their brokerages in both claims and regulatory litigation. I often receive referrals for legal services in representing the parties to mostly commercial and some residential transaction work, occasionally litigation and dispute resolution too.

I have other experience on industry boards as well, more significantly serving on the Commercial Brokers Association. Should the Board need further recommendation, you might want to ride the elevator to ask Chris Osborne for his input on my proposed candidacy.

As you know well from your experience, I am through my law firm an associate member of the Washington Land Title Association and have been for quite some time. You may recall soon after the Admission to Practice Rules were adopted by the Washington State Supreme Court, I was hired to represent the WLTA in its advocacy involving the IOLTA rules that were then being created. I have appeared in appellate litigation as an *amicus curae* for the Association. Together with you I have, off and on, performed work on and with the Judiciary Committee. I was active in the initial development of the Admission to Practice Rules. You and I also worked together with a few key others on the state statute defining abstractor liability. I am pretty sure I have served on other committees and in other capacities over the years, although I cannot recall off hand which of them; and, during my tenure in the title industry I recall serving on the Association's board.

Probably the best example of my investment in the escrow and title industries is employment by Stewart Title Guaranty Company as an officer of the Company, director of the National Title Services office in Seattle, as well as an underwriter with significant policy issuing authority. I was involved in closing and underwriting title nationally. My work at Stewart included recruiting, hiring, supervising and supporting escrow closers, all of whom were limited practice officers. I was daily involved in their selection, preparation and completion of legal documents in the course of closing commercial real estate transactions using LPB forms. Based on my education, training and experience, I am regularly engaged by lawyers throughout the Pacific Northwest region to consult on the standard of care for a reasonable and prudent closer in the capacity of a closing agent and in the limited practice of law. to opinions on these topics. Expert reviews, consultation and testimony is a growing part of my practice and keeps me sharp for my daily communications with and engagements to represent closers.

You may recall during my partnership at Williams Kastner as a member of the firm's real estate practice group, Mark Schedler was my partner and good friend. Mark and I have known each other for longer than I can remember, dating back to his employment with Jerry Long when my clients and I often hired Jerry as an expert consultant in the many escrow liability cases I defended beginning in the 1980s. Back then my clients in escrow liability cases were not limited to the large title underwriters and their agents, but included a number of independent companies closing residential and commercial transactions, Lucinda Vergason comes to mind, and law firms such as Edgar Rombauer and Revelle Reese & Hawkins. I have not asked him, but I expect Mr. Schedler, though retired from active practice, might be willing to serve as a reference for this application for a Board position. It occurs to me that I was the firm mentor to an associate and later partner, Marshall Ferguson, now King County Superior Court Judge Ferguson, who should be able to make a recommendation for my qualification for the open board position. Mark Schedler often encouraged me to become involved with the LPB, but it always seemed at the time I was too busy. I do not want to let another opportunity slip away to serve on the Board. I am guardedly optimistic that I could make a contribution to the good of the Order and would appreciate a chance to try.

I have been a speaker on a number of panels for escrow and legal professional continuing education courses. I have been a panelist with Paul Hammann, Dwight Bickel, Mark Schedler, Bill Reetz and many others (probably with you too, if I think hard enough). I doubt the Limited Practice Board will need their input, but I expect the usual suspects would be willing and able to comment on my application to serve on the LPB. This extensive experience in continuing education may apply to consideration by the LPB of disciplinary matters.

Since resigning as a member at Williams Kastner in 2020, I have pursued solo practice. My law firm's business is described on the website, which I would like to offer for the Board's consideration of my application for service. I closed my Seattle office in One Union Square (which is probably the explanation for the two of us not seeing each other as often these days), and represent clients in Eastern Washington much more than when I was primarily a Seattle lawyer. It has expanded my perspective. One of several examples is my experience in representing locally Land Title of Walla Walla County. The company officer is Phil Wasser who you may know from your participation in the WLTA; Phil is the son of a retired officer and company owner of the same name. I am the company's go-to legal counsel, weekly if not daily responding to questions and problems encountered by Eastern Washington LPOs, as well as answering title underwriting and real estate legal questions on short notice. As the state's escrow industry has grown through its experience with RON and as the practice has evolved in its services to parties, brokers, lenders and others, I have learned daily what the LPOs need to know and handle. I trust I could be a resource on the Board as well as an ambassador for its work and reputation. If it would be helpful in the Board's decision-making process, I suspect I could round up a few of the usual WLTA
