Purpose of Entity:

The LLLT Board derives its authority from the Washington Supreme Court under Rule 28 of the Admissions and Practice Rules (APR). The purpose of the LLLT Board is to oversee the LLLT license program, perform the responsibilities provided in APR 28(C)(2), including handling grievances and enforcing discipline against LLLTs under the applicable ethics and procedural rules.

Strategy to Fulfill Purpose:

The LLLT Board meets approximately six times a year to discuss topics of concern or that are relevant to the LLLT license and to accomplish responsibilities provided in APR 28(C)(2), including but not limited to proposing rule changes, addressing LLLT discipline issues, developing forms for LLLT use, and developing CLEs relevant to LLLT scope of practice. The LLLT Board has several committees serving various functions, including the Family Law Practice Area Committee, the Discipline Committee, the Nominations Committee, the Limited License Review Committee, and the Rules Committee, which also includes a Planning subcommittee.

How this entity's purpose helps further the mission of the WSBA "to serve the public and the members of the Bar, to ensure integrity of the legal profession, and to champion justice":

The LLLT Board serves the public by overseeing the LLLT license. Practicing LLLTs provide limited legal services in the practice area of domestic relations. Many LLLTs report serving primarily clients of low and moderate means, as well as providing pro bono services. The LLLT Board ensures the integrity of the legal profession by administering the LLLT discipline system, including handling grievances against LLLTs.

2024-2025 Accomplishments:

 Developed and conducted required supplemental education for LLLTs on the topic of Agreed Minor Guardianship Actions. LLLT Board Limited License Review Committee met monthly, gathering and reviewing
information on limited legal license types in an increasing number of other states and
assessing the LLLT license against the information gathered about other limited license
types to help inform possible improvements to the LLLT license and applicable rules.

Next Fiscal Year: 2025-2026 Goals & Priorities:

1	The Planning subcommittee of the Rules Committee will review the final recommendations of the Limited License Review Committee and propose to the LLLT Board corresponding amendments to APR 28 and the Regulations.

- Collaborate with the Committee on Professional Ethics to suggest amendments to the LLLT Rules of Professional Conduct (LLLT RPC), as needed.
