RCW 23B Sourcebook Guide

Legislative History: In 2005, the Corporate Act Revision Committee published the Washington Business Corporations Act (RCW 23B) Sourcebook that collected in a single volume the current version of RCW 23B, each prior version of each section of RCW 23B that has been amended, the official legislative history of each section, commentary prepared by CARC in connection with various amendments to RCW 23B proposed by CARC over the years, and summaries of judicial decisions from Washington and other Model Act jurisdictions. In 2007, 2010, and 2015, the second, third, and fourth editions were published, bringing the Sourcebook current through the 2007, 2009, and 2011 legislative sessions, respectively. The Sourcebook has now been reissued in a fifth edition, current through the 2015 legislative session. The 2016 fifth edition replaces all prior editions.
