The Meeting was called to order at 12:05 a.m.

1. Retreat Minutes

The January 30, 2016 Reatreat Meeting Minutes were unanimously approved.

2. Treasurer's Report

Bruce believes we should have a 2 year reserve fund. Our Annual CLE will likely not be in the black

3. **BOG Report** - Governor Kim Risenmay

7 public BOG meetings a year, one of which is Olympia
Judicial Recommendation Committee reported on candidates
Executive Committee (not open to public) concern: US Supreme Court opinion, had to
do with Dentists. State agency effectively preventing non-dentists from providing dental
services. Antitrust violation. Bar is in 3rd branch of government. State Supreme Court
has plenary power to regulate. We've acted pretty autonomously in the past. WSBA
must set up procedures for Court to actively review and approve.

Bylaws Workgroup: Supreme authorized WSBA governance review. WSBA sent governance report to Supreme Court which was approved. Bylaws Group formed to incorporate those changes and to make changes to Bylaws. Be on the lookout for Bylaws revisions! These are very important and affect all WSBA members. READ THEM!!

ABA Resolution 105 approved by HOD: 10 recommendations. WSBA has urged Supreme Court to be one of the first states to adopt.

Supreme Court very concerned about access to justice, it's declining. Kim predicts LLLT program will expand. If WSBA is supervising both attorneys and non-attorney providers, what should be the membership status? Full or limited membership? What about leadership opportunities? Could a LLLT become WSBA President?

WSBA Legislative Committee and then there's the BOG Legislative Committee. Should they be merged? BOG Committee Chair recommended it be abolished

Kim is on the budget and audit committee. Kim believes WSBA has done a good job of paring the fat out of the budget. Credit card fee saved bar \$300,000. If we stayed at \$385 bar dues, WSBA will go insolvent in 3 years. WSBA staff is smaller now. Cost of labor increases 3%/year. WSBA fees will likely go to \$400/year.

38 are mandatory bars

Most of them (⅔) are unified bars, e.g. services to members WSBA and Supreme Court are in agreement to maintain a unified bar Everyone hopes Sections will increase membership and increase member benefits

30,000 in state WSBA members 11,000 belong to Sections 19,000 total Section members

BOG elections are underway Open positions in 10th and 2nd One At Large position on BOG BOG District members elect the at-large

Sections Workgroup: BOG authorized this committee to re-do. 5 positions open for Section Leaders. Kim has not heard anything about using Section reserves for anything other than Section-related things.
