Legal services that count for Pro Bono MCLE credits include:

- Ghostwriting
- Drafting pleadings, briefs, declarations or orders
- Document review
- Conducting legal research
- Negotiating
- Making limited appearances
- Advising on court procedures and courtroom behavior
- Coaching on strategy or role playing
- Preparing exhibits
- Organizing discovery materials
- Drafting contracts and agreements
- Providing legal guidance or opinions
- Providing direction to resources such as local and state rules

Benefits of volunteering:

- Earn 24 CLE credits
- Access to free CLE seminars
- Transition into Emeritus Pro Bono Status
- Court fees waived for clients through a QLSP (GR 34)

QLSP Criteria

Qualified Legal Service Providers (QLSP) are not-for-profit legal service organizations whose primary purpose is to provide legal services to low-income clients in Washington state. QLSPs must:

- **Provide at least two hours of CLE-accredited training** for their volunteers (either live or recorded seminar).
- Have a client financial screening mechanism in place to ensure clients are low-income.
- Either provide malpractice insurance for volunteers or have a policy in place to require that all volunteers have alternative malpractice insurance.
- Be in Washington state or predominantly serve Washington state residents.
