



2019 LICENSE FEE PAYMENT PLAN FOR LICENSED LEGAL PROFESSIONALS

OVERVIEW

- As set forth in the table below, you may pay your 2019 license fee in up to five monthly installments. *To take full advantage of the plan, sign up and pay the first installment in October 2018.*
- All payments are due by the first day of the month.
- The \$30 [Client Protection Fund](#) assessment set by the Supreme Court is included in your first payment.
- Optional: You may take the [Keller deduction](#) or donate to the [Washington State Bar Foundation](#) (WSBF) and/or [Law Fund](#) with your last payment.
- Mandatory: You will receive annual licensing materials in November. All [licensing requirements](#), including payment, must be completed by February 1, 2019. A late fee will be assessed February 2. Failure to comply with licensing requirements may result in a Supreme Court order of suspension (Supreme Court Admission and Practice Rule 17).
