

**205 Candidates Pass Winter 2017 Washington State Lawyer Bar Exam**

SEATTLE, WA [April 14, 2017] — The Washington State Bar Association (WSBA) administers the licensing and renewal process for Washington licensed legal professionals on behalf of and under rules adopted by the Washington Supreme Court. The WSBA announced that 205 candidates passed the Uniform Bar Exam (UBE) administered in February 2017. Administered over a two-day period, the UBE is a substantive law exam that includes multiple choice, essay and performance questions. The other required component of the Washington Bar Exam is an exam on professional responsibility (the Multistate Professional Responsibility Exam or MPRE). Completion of a separate online educational component and online exam addressing specific areas of Washington law (the Washington Law Component) is also required to qualify for admission.
