

RPC Conversion Table

The following table includes all amendments to the Rules of Professional Conduct ("RPCs") since 2006. In using this concordance table, lawyers are reminded:

- Official comments now accompany the RPCs and should be consulted for guidance in applying the rules.
- The RPCs are not static. Periodic proposed amendments are available on the Washington courts' web site.
- The purpose of the conversion table is to assist lawyers in locating sections in the "new" rules corresponding to provisions in the "old" rules. Lawyers should carefully review the content of the new rules as there were many amendments that did not change the numbering but did alter the content.
- Any change in the wording of the rule is indicated by an asterisk in the table.
